You may wish to retain a photocopy of this document for your records.

**You may, along with this form, submit documents confirming available funds for the annual costs of study, such as online deposit accounts or a signed bank letter verifying the ability to pay all educational expenses. Funds must be currently available or liquid; bank statements must be dated within 12 months of your start date at Boston University and written in English.**
